

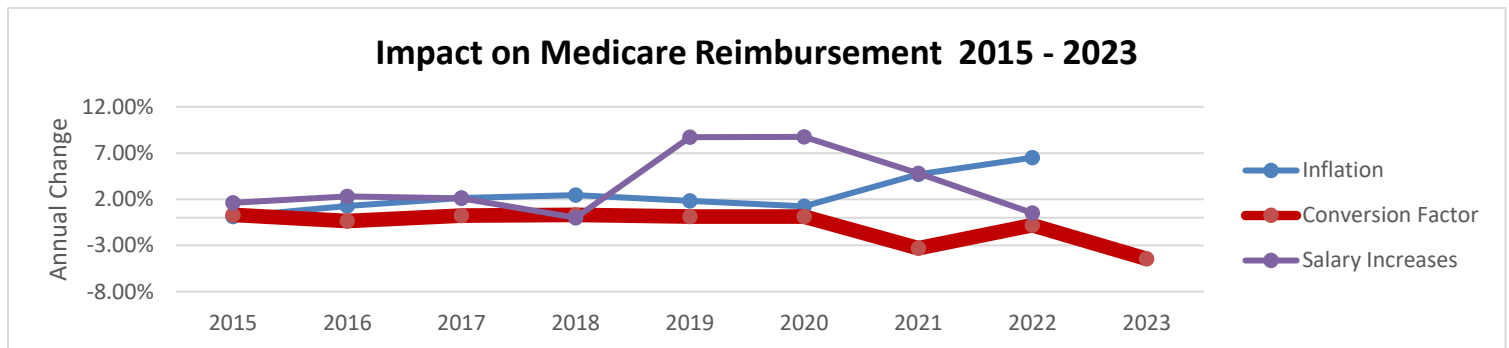
Stop Payment Reductions for Rehabilitation Providers

The National Association of Rehabilitation Providers and Agencies (NARA) opposes further reductions in Medicare reimbursement to Physical Therapy, Occupational Therapy and Speech Language Pathology providers. Below is a list of the reimbursement reductions during from 2011 - 2024:

Impact of Reimbursement Reductions

- Clinic closures leading to reduced accessibility to therapy services crucial for beneficiaries recovering from falls, joint replacements, muscle weakness, and other injuries.
- Disproportionate impact of beneficiaries that are high-risk and in rural and underserved areas
- Inability to meet rising salary requirements for qualified rehabilitation professionals due to inflation and the increased cost of living, exacerbating the workforce shortage
- Diminished capacity to invest in the essential technology needed for advancing practice areas



Recommendations to Congress:

- **Support and Pass HR 4878 and S 2459:** EMPOWER Act ensures supervision requirements for outpatient physical therapy and occupational therapy services furnished through private practice may not be more stringent for purposes of Medicare coverage than under state law. This also includes a study of the impact on rural and underserved areas. Cost Savings Reference: [Dobson Report 9.2022](#)
- **Support and Pass HR 2474:** replaces separate conversion factors with just one, updates annual percentage increase in the Medicare Economic Index (MEI). Support Senate introduction of companion bill.
- **Support and Pass HR 7279:** REDUCE Act to reduce administrative burden on certification of plans of care. Support Senate introduction of companion bill.
- **Support and Pass HR 6545:** updates budget neutrality threshold and sets more timely updates to direct costs used to calculate practice expense RVUs. Support Senate introduction of companion bill.
- **Support and Pass HR 7618 SAFE Act:** adds new falls prevention policy to this program providing for a referral to a separate falls risk assessment and preventive services provided by a physical therapist or occupational therapist if a physician discovers during the AWV the beneficiary has fallen within the previous calendar year. Support Senate introduction of companion bill.

The services rendered by rehabilitation providers are crucial for Medicare beneficiaries, especially those who are aspiring to age in place. However, the cumulative effect of annual reimbursement reductions will inevitably exacerbate access to care challenges for Medicare beneficiaries seeking physical therapy, occupational therapy, and speech-language pathology services.
